

## Visa information

We encourage foreign attendees to apply for visas as early as possible. Please consult or seek advice from your local embassy or overseas mission if you encounter problems during your application. They have the expertise and experience to handle visa-related matters efficiently to ensure a smooth process.

### VISA-Exempt Entry

Passport holders of the following-mentioned nationalities can stay for up to 14-90 days without applying for a visa.

Duration of Stay	Country
90 DAYS	Andorra, Australia, Austria, Belgium, Bulgaria, Canada, Chile, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Eswatini*, Finland, France, Germany, Greece, Guatemala, Haiti, Hungary, Iceland, Ireland, Israel, Italy, Japan*, Republic of Korea, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Marshall Island*, Monaco, Netherlands, New Zealand, North Macedonia*(effective till March 31, 2025), Norway, Palau, Paraguay, Poland, Portugal, Romania, San Marino, Slovakia, Slovenia, Spain, Sweden, Switzerland, Tuvalu*, the United Kingdom, the United States of America*, and Vatican City State.
30 DAYS	Belize*, Malaysia, Nauru, St. Kitts and Nevis*, Saint Lucia*, Saint Vincent and the Grenadines, and Singapore.
14 DAYS	<ul style="list-style-type: none"><li>– Thailand (effective till July 31, 2024)</li><li>– Brunei (effective till July 31, 2024)</li><li>– Philippines (effective till July 31, 2024)</li></ul> <b>Holders of Brunei, Philippines and Thailand passports must have: A proof of accommodation (hotel) booking, host / sponsor's contact information and sufficient travel funds.</b>

### eVISA

Passport holders of the following-mentioned nationalities are eligible for an eVisa.

Duration of Stay	Country
30 DAYS	Bahrain, Burkina Faso, Colombia, Dominica, Ecuador, Kiribati, Kuwait, Mauritius, Montenegro, Oman, Panama, Peru, Qatar, Saudi Arabia, Solomon Islands, Turkiye, United Arab Emirates, Kosovo and Bosnia-Herzegovina.

\*Please follow the steps below to complete your eVisa application.

1. Fill out and submit the application form [online](#).

\*Delegate will receive an Ecode at this step. Please note that Ecode will be used when applying for eVisa.

2. Complete the payments.
3. Wait for the approval of the eVisa.

\*Please be reminded that the Bureau of Consular Affairs may request other relevant documents.

4. Provide eVisa and Official Invitation Letter in English (Colored, Clear, and legible) when entering Taiwan.

### **Hong Kong and Macau**

Residents from Hong Kong and Macau must hold an Entry Permit to enter Taiwan.

– Those who have never entered the Taiwan area.	1. Submit the application form <a href="#">online</a> . 2. Wait for the approval of Entry Permit, and it takes at least 5 working days. 3. – Those who have ever been allowed to enter the Taiwan area. – Those who were born in Hong Kong or Macau.	1. Complete the application form <a href="#">online</a> . 2. ### **People's Republic of China (PRC) Passport Holder**

Please email the following documents to ([secretariat.ocpapak2025@gmail.com](mailto:secretariat.ocpapak2025@gmail.com)) by 4 May 2025 for entry application :

1. Application Form: Please contact the Secretariat for the form. It must be filled out electronically
2. A color copy of your Mainland Chinese passport with a validity of at least six months
3. A color copy of your Mainland Chinese resident ID card or any identity proof
4. A color photo meeting the following requirements:
  - Unaltered and identifiable
  - Taken within the last two years
  - Dimensions: two-inch, 5cm x 5cm
  - Without a hat, without glasses, without color contact lenses
  - Person's head from the top to the bottom jaw not less than 3.2 cm and not more than 3.6 cm
  - A front-facing half-body photo

- All facial features must be clearly visible with no obstruction in the photo
  - Composite photos are not allowed
  - White background
  - JPG format
5. Proof of relevant professional expertise or current job position.
  6. Proof of income
  7. Expected arrival and departure flight dates

Remarks :

- If the applicant is currently in a foreign country, Hong Kong or Macao, they should also provide a copy of their re-entry visa, residence permit, Hong Kong or Macao ID card.
- Additional visa fees will be charged upon successful application.
